He co-designed and implemented the national training programme of regional consultants for guidance in Finland 2002-2005. He was a project member in designing the national portal on guidance 2000-2004. His responsibility was the design and maintenance a virtual resource centre for guidance practitioners and policy makers.

He was in charge a national research project in the design of cross-sectoral networked guidance service provision 2004-2007. He coordinated the national input for the the OECD and European Union evaluations on guidance policies in 2000-04.
